## CENTERSTAGE PERFORMING ARTS ACADEMY WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT.

1. In consideration for participating in a performance program offered by Center Stage Performing Arts Academy (CSPAA), I hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE CSPAA, the Board of CSPAA or any employees, agents or volunteers of CSPAA from any and all liability claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage or injury, including death, that may be sustained by my child(children), or to any property belonging to me or my child(children) WHETHER CAUSED BY NEGLIGENCE OF THE RELEASEES, or otherwise while participating in such activity, or while in, on or upon the premises where the activity is being conducted or in transportation to and from said premises.
2. To the best of my knowledge, my child (children) can fully participate in this activity. I am fully aware of the risks and hazards connected with the activity, including but not limited to the risks as noted herein, and I hereby elect to allow my child (children) to voluntarily participate in said activity, and to enter the above named premises and engage in such activity knowing that the activity may be hazardous to my child (children) and my child (children's) property. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by my child(children), or any loss or damage to property owned by my child(children), as a result of being engaged in such an activity, WHETHER BY NEGLIGENCE OF RELEASEES or otherwise.
3. I further AGREE TO INDEMNIFY AND HOLD HARMLESS THE RELEASEES from any loss, liability, damage or costs, including court costs and attorney's fees that may incur due to my child(children's) participation in said activity, WHETHER CAUSED BY NEGLIGENCE OF RELEASEES or otherwise.
4. It is my express intent that this Release and Hold Harmless Agreement shall bind the members of my family and spouse (if any), if I am alive, and my heirs, assigns and personal representative, if I am not alive, shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE the above named RELEASEES. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the Province of British Columbia.
5. I UNDERSTAND THAT CSPAA WILL NOT BE RESPONSIBLE FOR ANY MEDICAL COSTS ASSOCIATED WITH AN INJURY MY CHILD (CHILDREN) MAY SUSTAIN.

I and my child (children) further agree to become familiar with the rules and regulations of CSPAA concerning student conduct and not to violate said rules or any directive or instruction made by the person or persons in charge of said activity and that my child (children) will further assume the complete risk of any activity done in violation of any rule or directive of instruction.
7. I also understand that I should and am urged by CSPAA to obtain adequate health and accident insurance to cover any personal injury to my child (children) which may be sustained during the activity or the transportation to and from said activity.
8. I ALSO UNDERSTAND THAT I AM RESPONSIBLE FOR ANY DAMAGE MY CHILD (CHILDREN) CAUSE TO THE FACILITIES.
9. IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Waiver of Liability and Hold Harmless Agreement, I understand it and sign it voluntarily as my own free act and deed, no oral representations, statements or inducements, apart from the foregoing written agreement have been made. I am the parent or legal guardian of a minor child (children) participating in the program and am fully competent to consent his/her participation, and I execute this Release for full, adequate and complete consideration fully intending to be bound by same.
